- The City of Beaverton is recruiting for boards, commissions and committees to serve 1- to 3-year terms.
- A list of items with the most holds for September was distributed to the board.

Presentation of Current Statistics:

- Abigail provided the board with September 2015 circulation reports for BCL.
- John Finn, Manager at Murray Scholls Branch library, reported that statistics are way up. Gate count was up 47% this September over last September, and program attendance at Murray Scholls was up more than 1500%!
