Chair Gautam Kottapalli called the meeting to order at 6:31 p.m.

Read and Approve Minutes of May 9, 2018, Meeting:

- Chair Gautam Kottapalli called for the approval of the May 9 minutes. Maureen Inouye-Harrison moved and Pam Wagoner seconded the motion. Motion CARRIED.

Public Forum:

- Adrienne Doman Calkins, the Sherwood Library Manager, visited to learn about Beaverton's library board meeting.

Council Report by Councilor Mark Fagin:

- City Council will approve the library budget of materials and services, the hours change at both libraries, and additional staff to support the new hours.
- Council voted to ban overnight parking and to approve an ordinance that will be effective in July. Staff will make full recommendation to connect the homeless with resources that will help get them off Beaverton streets.

- The Foundation board is working with an event planner to prepare for next New Year's Eve event.

- Victoria said there is good feedback from May's book sale and Friends will sponsor two book sales per year.

Old Business:

Victoria distributed a second draft of library Bylaws and the following revisions were as follows:

- Article III: Membership, no. 3. Term of Office - Add wording "Members may serve two full consecutive terms per O.R.S. 357.465".
 - Nancy Nkiwane moved and Pam Wagoner seconded the motion. Motion CARRIED.
- Article III: Membership, no. 7. Alternates - remove wording "and are non-voting members".
 - John Henshell moved and Maureen Inouye-Harrison seconded the motion. Motion CARRIED.
- Article IV: Officers, no. 2. Term - should read: The term of office for an officer begins with the last Board meeting of the calendar year and lasts for one year.
- Article IV: Officers, no. 4. Election of Officers - should read: At the first Board meeting of the calendar year, Board members shall elect officers.
- Article V: Quorum & Voting, no. 1. Remove wording "Alternate board members do not count towards quorum".
- Article V: Quorum & Voting, no. 2. Add wording "An alternate may vote when a member is absent.
- Numeric order.
 - Maureen Inouye-Harrison moved and Pam Wagoner seconded the motion. Motion CARRIED.
- Chair Gautam Kottapalli called for the approval of the revisions to the second draft of the library Bylaws. Maureen Inouye-Harrison moved and John Henshell seconded the motion. It was approved by the Board members.
- May comment cards were distributed.

New Business:

- The Youth Services report will be discussed at the next meeting.
